

**Subject: Buying House Registration for Apparel Town BD LTD.**

**Terms and conditions:**

1. This Registration Certificate shall not relieve any of the statutory obligations of the importer of buying house. The buying house authority shall be responsible for any shortage caused by any breach of condition or failure to comply with the rules.
2. This Registration Certificate shall have an irrevocable and non-transferable character in any financial or non-financial government or non-governmental financial organization or implementing the buying house.
3. If any change happens in ownership or address of the buying house must be notified to the Department of Textiles immediately.
4. The registered buying house should extend their full support to any enquiry or inspection conducted by the government concerning importation.
5. The buying house authority should inform the Department of Textiles in case of the government pro-credit received.
6. Any violation and breach of the Department of Textiles may void the buying house at any time.
7. The buying house authority should maintain and provide training facilities for the knowledge training for the students of the Textile Educational Institute of the Department of Textiles.
8. Bangladesh Labor Act 2006 should be followed. Child labor should not be employed in any circumstances.
9. The buying house authority must raise appropriate security amount that are sanctioned by the existing laws of the country.
10. The authority shall have to provide the most facilities, especially from IRB, New-credit facility (New for the existing credit) together with a payment of weight and size table accounts for equal pay for the male and female employees in order to provide gender equality. In addition, buying house should provide low-cost credit, women facilities, and general working conditions between male and female employees.
11. The Department of Textiles will not be liable for any loss or damages related with the issuance of buying house.
12. The registration certificate may be suspended and cancelled either in part or whole and new condition to be added or any term to be added without any notice to the holder.
13. The authority shall have to ensure that Registration includes export-visibility data. Once this data Registration will be cancelled after the visibility period. Renew applications must be submitted 60 days before Registration validity date request.
14. The Department of Textiles reserves the right to cancel the registration of the importer if any of the above conditions or any part of the conditions is violated.
15. The authority will be requested to update Registration Number in all their related correspondence with DIT.
